## STALLHOLDER INFORMATION AND CONDITIONS OF TRADE

Welcome and thank you for attending our GEM SHOW 2026.

Gem Show Location is the Townsville Sports Precinct, 24 Burke Street, North Ward.

### Site Access:

- Bump **IN** times (other than trailer sites):
  - Friday 17<sup>th</sup> – From 9:30am
    - Vehicle movement times are **9:30am to 2:00pm** and **3:00pm to 6:00pm**.
    - **NO** Vehicles are allowed onsite between 8:30am to 9:30am and 2:00pm to 3:00pm, or while there is school movement onsite.
  - Saturday 18<sup>th</sup> – From 6:30am
    - Vendor bump-in from **6:30am to 8:00am**.
    - There is **NO vehicle access Saturday morning**.
    - Trading commences at 9:00am on Saturday 18<sup>th</sup> July.
    - See site map for access gate and vendor parking.
- Bump **IN** times – Trailer sites:
  - Friday 17<sup>th</sup> – Vendors with trailer sites will be able to bump in on Friday morning between 7:30am to 8:30am and 9:30am to 11:30am, to allow space to manoeuvre the trailers onto site. The earlier we get you in the better.
- Bump **OUT** Sunday will commence once clearance has been given by the Club President after the Gem Show closes once all members of the public are offsite.  
NO, vehicle movement will be allowed until such clearance is given.
- All vendors will be given 2 x Vendor Access Passes per site on arrival; these must be always visible while onsite at the event and must be worn for the duration of the event.
- All sites will be numbered. Vendors **MUST** stick to their allocated site/s and **NOT** exceed their site limits as marked. Site sizes this year are 3.5m x 3.5m.
- Vehicles are not permitted to be left onsite for the duration of the event. If your vehicle remains on site, it cannot be moved for the duration of the event.
- Vehicles **MUST NOT PARK** in Burke Street during show opening hours, we will have designated parking areas for vendor vehicles.

## **Terms and Conditions:**

- All bookings must be paid in full before bumping into site.
- Stallholders must operate between the opening and closing times of the Gem Show, these are: **9:00am to 4:00pm on Saturday 18<sup>th</sup> July**, and **9:00am to 2:00pm Sunday 19<sup>th</sup> July**.
- Stall Holders providing their own marquees within their allotted space must ensure they are weighed down with a minimum of 10kg per leg. Marquees **cannot** be pegged into the ground due to underground services.
- Stall Holders acknowledge that the venue is an open-air space and that no refunds will be made due to weather conditions.
- Stallholders must ensure their goods are secured when the site is not attended. Townsville Gem & Mineral Club will not take responsibility for unsecured goods left onsite. Security Officers will be onsite overnight on Friday and Saturday nights. Please note this does not guarantee your site will be secure from theft.
- No Camping is allowed onsite at the venue.
- Stall Holders are to always conduct themselves in a professional and polite manner.
- All material for sale should be correctly labelled. Treated stones and synthetic, simulant material or lab created material is required to be labelled as such.
- Stall Holders will not knowingly impart false facts for information, or defraud, or mislead the public by presenting non-genuine facts and items for sale.
- Stall Holders are not permitted to raffle or auction any goods or materials.
- The sites must remain clean and tidy during the Gem Show and remain clean at the end of trade on the final day of the Gem Show.
- Animals will not be permitted on site as a requirement of the Venue. Registered service, assistance and support animals will be permitted. These animals must be easily identified and proof may be required.
- All application forms and payment must be received by 1st July; last-minute applications may not be guaranteed a site.
- Stall Holders are to follow instructions given by the Gem Show Coordinators, Committee members and volunteers.
- Sites allocated are final and no request for changes will be accepted on the day.
- If a trader cancels their booking within 14 days of the event, and the site cannot be resold, the site fees will be forfeited. If the site is resold a full refund will be made.

## **Goods Sold**

- It is preferable that goods sold be related to lapidary craft. (E.G., cutting & polishing of gemstones, carvings, gems, gemstone jewellery, lapidary tools, and machinery etc.).
- No food or drink is to be sold unless prior approval is given by the Townsville Gem and Mineral Club Committee.

## **Payment**

Once your application has been processed and approved you will be issued an invoice based on your application. Payment is due 14 days from receipt of invoice. Invoices issued 14 days prior to the event must be paid immediately.

## **Site Numbers**

We will contact you at least 14 days prior to the event with your site number and a site map indicating the location of your site.

Please note that NO site changes will be made on the day.

## Text Messaging

- All vendors mobile numbers will be entered into a group text messaging system to enable us to communicate quickly and effectively.
- **We will provide you with a dedicated mobile number closer to the Gem Show.** We will ask you to enter this number into your contacts as "Townsville Gem Show 2026" so you know that the message is from us.
